Objectives

1. Reinforcing national base

- Not a new body created at a national level
- National correspondents already in place
- Coordination of the work carried by them by establishing the responsible for the functioning of the ENCS
- Implementation within 2 years

2. Key players meeting point

- Eurojust National Correspondent (Article 12)
- National Correspondent for terrorism matters (C.D. 2005/671/JHA)
- National Correspondent for EJN + 3 contact points
- National Members or Contact Points for following networks: JITs, Genocide Network (C.D. 2002/494/JHA), Asset Recovery Offices Cooperation (C.D. 2007/845/JHA) and Network Against Corruption (C.D. 2008/852/JHA)

2. Key players meeting point

- Maintain their status under national law
- The tasks exercised within ENCS shall not affect their primary function
- NC for Eurojust responsible for the functioning of the ENCS

3. Facilitate the carrying out at a national level of the tasks of Eurojust

- Ensuring the provision of the CMS with efficient and reliable information
- Assisting the allocation of cases between Eurojust and EJNI
- Facilitating relations between National Member and national authorities
- Maintaining the link with the Europol National Unit

4. Facilitate the exchange of information

- Connection of ENCS to the Eurojust CMS (5 years)
- At the charge of the general budget of the EU
- NC for Eurojust, NC Terrorism and NC EJN shall be connected
- The contact points or national members of networks may be connected
- Rules on content, data protection and access to the CMS and TWF apply
- Not intended as a channel for transmission of requests for judicial cooperation or to replace the direct contact between judicial authorities

4. Facilitate the exchange of information

Persons in ENCS may only have access to:

- index, unless expressly denied by NM

(extend of access decided by MS/ consultation NM, at least enough to access TWF)

- TWF opened or managed by his MS

(extend of access decided by NM)

- TWF opened or managed by other MS but to which his NM has access unless expressly denied by NM

4. Facilitate the exchange of information

- Connection of ENCS to the Eurojust CMS (5 years)
- At the charge of the general budget of the EU
- NC for Eurojust, NC Terrorism and NC EJN shall be connected
- The contact points or national members of networks may be connected
- Rules on content, data protection and access to the CMS and TWF apply
